School Parking Regulations:

1. All cars parked on school campus must be registered with the school and must display the current permit. Cars without a permit will be cited and or towed away at owner's expense. Senior parking must display both senior hang tag and parking permit.
2. Parking is strictly limited to the student parking area ONLY. DO NOT park in Staff parking, handicapped area or in front of a trash dumpster. DO NOT BACK INTO A STALL, OR PARK IN TWO SPACES.
3. All students must be licensed and covered by insurance before purchasing a permit. The school is not responsible for the car or its contents.
4. The student parking lot is out of bounds during the school day. Cars are not to be used as lockers.
5. Riding in the back of pickups is prohibited. Anyone doing so will be issued a citation. Speed limit is 5 miles per hour. Students displaying any form of reckless driving will be sent to the TCHS Resource Officer.
6. Parking regulations are strictly enforced. It is considered a **privilege** to park in the student parking lot. In addition to being cited, violators may face suspension of driving privileges, towing of car, and /or suspension from school.
7. Students applying for parking permits must bring the following to receive the parking pass: Valid Driver's License, school id, this completed form, \$5.00, and Proof of current Insurance card on the car you are registering.

Agreement: I understand and agree to the following: The Parking sticker must be positioned inside front lower driver's side corner of the windshield. All cars parked in Temescal Canyon High School's parking lot must have a parking sticker in to be identified in case of emergency. Another student may not use the parking sticker.

Unauthorized use of the parking sticker is treated as a serious violation of the school code of conduct. Illegally parked cars may lose their parking privileges and be towed away. It is fully understood that the District is in no way responsible, nor does the District assume liability, for any theft or damage to the vehicle listed.
